CONDITIONS OF AWARD FOR SAINT GILES EDUCATIONAL TRUST BURSARIES FOR THE DISABLED

ELIGIBILITY

Persons who are affected by a condition that markedly restricts their ability to function physically, mentally, or socially and who have insufficient funds for studying and who are older than 16 years. Preference will be given to residents of the Durban Metropolitan Unicity. The Trustees will consider which applicants are likely to benefit the most over the longest period of time when making an award. All awards are made at the sole discretion of the Trustees who reserve the right to discontinue an award without notice at their sole discretion.

This application form is a preliminary application only. Applicants may be required to undergo medical or other examinations by appointees of the Trustees and to provide more information prior to

FIELD OF STUDY

The subjects chosen must preferably provide the ability for the applicant to be eligible to continue with post school studies.

VALUE

Adapted to meet the needs of the student and subject to availability.

DURATION

Renewable annually at the sole discretion of the Trustees subject to satisfactory results and available funding. Academic performance and changed financial circumstances may result in cessation of bursary funds.

TENABILITY

Any institution of secondary education within the Durban Metropolitan Unicity recognised by the Trustees.

The above conditions of award will be applied by the Trustees of the Saint Giles Educational Trust when awarding a bursary. In exceptional circumstances these conditions may be waived at the sole discretion of the Trustees.
